Norms for Fixing Fees

1. Regulatory Compliance

- 1.1 The school strictly follows the fee regulations prescribed by:
- 1.2 The CBSE guidelines on fee structure.
- 1.3 The State Education Department and any applicable fee regulation laws.
- 1.4 The School Management Committee (SMC), which oversees and approves any changes in fees.

2. Criteria for Fee Determination

3. Process of Fee Fixation and Revision

- 3.1 The School Management Committee (SMC) reviews and finalizes the fee structure annually.
- 3.2 Any revision in fees follows the prescribed norms and is subject to prior approval from the competent authorities.
- 3.3 Parents are informed well in advance about any changes in the fee structure.

4. Transparency & Communication

- 4.1 The detailed fee structure is displayed on the school website and is accessible to parents at any time.
- 4.2 The school does not charge any capitation fee or donations in any form.
- 4.3 All receipts for fee payments are duly issued to parents.

5. Breakdown of Fees

5.1 The fee structure consists of the following components:

- a) Tuition Fee: Covers academic instruction and curriculum-based learning resources.
- b) Transport Fee (if applicable) It is optional
- c) Mess Charges (if applicable) It is optional

6. Payment & Refund Policy

6.1 Fees must be paid as per the scheduled due dates communicated by the school.

6.2 Late payment may attract a penalty as per school policy.

6.3 Refund of fees is subject to the school's refund policy, which will be clearly mentioned in the admission guidelines.
